When I Knew My Program Was Working

Recently I was thumbing through a publication from my old place of employment. As I did so it occurred to me that the document was very well laid out and particularly informative. I was just beginning to get excited about the many programs and classes I might sign up for when I turned the page and there SHE was! The person whom I credited with getting me fired from my job and causing me a mini nervous breakdown. My sworn enemy, my arch nemesis right there on the page smiling up at me! The person whose demise I spent hours and hours plotting. I quickly scanned her face for any signs of age, weight gain, or any indication of the years of pain and suffering SHE caused me. After all, SHE deserved to be ugly after all SHE put me through! Instead all I saw was the excitement in her face. What did SHE have to be so excited about? Didn't SHE know she was a bad person

who had caused me so many years of grief? The mini nervous breakdown I had because of her changed my life forever. I could no longer work and I was forced to seek therapy and eventually Al-Anon.

Wait. Did someone just say "Al-Anon?" Suddenly, I realized that although I HAD harbored negative thoughts about HER for so many years, I no longer ACTUALLY felt those emotions


All Al-Anon and Alateen members are invited to attend!

looking at her picture. Instead my mind was filled with thoughts like, "Live and Let Live" and "No one ever found serenity through hatred." I took a better look at HER picture and asked myself, "Did I deserve the wrongs SHE perpetrated on me so many years ago? No. "Was my anger justified at the time?" Yes. "Did that anger serve me then and does it serve me now?" Yes and No. I realized that while I wasted precious time being upset by what happened to me so many years ago, my hurt eventually lead me seek out Al-Anon where I had found serenity in the 12 Steps and its fellowship. I also realized that because I was not able to work during those tough years, I was also given the gift of time: Time spent with my family; time spent exploring hobbies and interests; time spent in meditation and healing. So while my feelings then might have been justified and may have served me to steer me in the right direction toward serenity, those same negative feelings were no longer necessary and would actually impede my spiritual growth.

Wait, was that gratitude for HER I just heard knocking at the corner of my mind? Was it possible that SHE actually gave me a gift or at least set me on a path in the right direction to find it? Suddenly this whole thing was no longer about HER but about ME! Regardless of her motives at the time, it was my choice then to be angry and upset, my choice to use that anger to seek out a change in my life that led to my eventual serenity. And, more importantly, it was my choice now to be grateful to my Higher Power and move forward with my spiritual journey. I looked at the picture again and then proceeded to read the accompanying article. SHE had been promoted to the very position I held before I was fired. When I read those words I waited for the jealousy to hit me. When that didn't happened I mentally thanked my Higher Power and flipped the page SHE (now known as 'she') had so skillfully laid out. I found the class I wanted to sign up for on that very page. As I eagerly dialed to register for the class I hoped she might answer the phone so I could tell her what a great job she was doing in her new position. As the phone began to ring I realized that I now had proof my program was working. My attitudes, actions and feelings were changing little by little, "One Day at A Time." I mentally thanked my Higher Power again as I waited for someone to answer. . . Then I realized "someone" already had!
